Monthly pricing is \$50 for washer and dryer, or \$30 for washer only, or \$30 for dryer only. Normal maintenance and repairs due to ordinary wear and tear are included. Damage caused by misuse or neglect may be charged according to the Damage Fee Schedule. Payments are due monthly in advance. Late fees apply after a grace period. Failure to maintain payment may result in termination of this agreement and retrieval of the equipment with reasonable notice, consistent with California law.

Washer and Dryer Rental Subscription Agreement

Agreement Terms

1. Term. This is a month-to-month subscription that renews automatically unless canceled.
2. Pricing and Billing. The customer agrees to recurring monthly credit card charges on the billing date.
3. Late Fees. A five day grace period applies. Thereafter, a \$10 late fee plus \$5 per day may be charged, capped at \$50 per billing cycle, agreed as reasonable under California Civil Code Section 1671.
4. Maintenance. SpinReady Rentals covers normal wear and tear. The customer is responsible for damage caused by misuse, neglect, unauthorized repair, pests, flooding, fire, or electrical issues not attributable to the equipment.
5. Prohibited Actions. The equipment may not be sold, subleased, tampered with, disabled, or relocated without written consent.
6. Non Payment and Retrieval. If payment is more than ten days past due, SpinReady Rentals may terminate this agreement and retrieve the equipment with reasonable notice and without breaching the peace.
7. Damage Fee Schedule. Minor repairs \$50 to \$100. Moderate repairs \$100 to \$200. Major repairs \$250 to \$500. Total loss or non return up to replacement cost, not to exceed \$1,200 per unit.
8. Limitation of Liability. SpinReady Rentals is not responsible for damage to clothing or personal items.
9. Cancellation. Customer may cancel with at least seven days written notice. No partial month refunds.
10. Consumer Rights. Nothing in this agreement waives rights under California law.
11. Governing Law. California law governs this agreement.
